# OBJECTIVES





# OBJECTIVES

Funding for these charity projects will come from the finances of the AAAA, which consist of various revenues, donations or contributions. All financial expenditures will be carried out in a highly clear and transparent manner.

# MEMBERSHIPS

## **General benefits for members:**

- Opportunity to participate to the meetings of AAAA
- Publication in the AAAA Newsletter (name, position, profile link)
- Realizing and participating in charity projects in Asia
- Integration in the AAAA business network through annual mailing of the updated membership list
- Opportunity for participation in corresponding art and cultural events

## **Obligation:**

- Participation in a minimum of 1 of the regular meetings/dinners of the AAAA
- Positive and continuous representation of the values and charter of the AAAA
- Acquisition of new members for the benefit of every member of the AAAA
- Support of each member with exchange of ideas and friendly assistance

# MEMBERSHIPS

## 1. Individual Membership

Any individual person over the age of 16 years is allowed to become an individual member. This individual member needs to be nominated by an existing member and thereafter endorsed by a board member.

- EUR 250 initial fee
- EUR 100 yearly fee

## 2. Couple Membership

Any couple is welcomed to join us through this couple membership. This couple needs to be nominated by an existing member and thereafter endorsed by a board member.

- EUR 250 initial fee per couple
- EUR 180 yearly fee

# MEMBERSHIPS

## 3. Corporate Membership

Any company which currently (or will be operating in the next 12 months) operates within the Austrian, Asian or African region area; have a minimum of 5 employees and officially registered in the respective regions (e.g. GmbH, AG, Ltd. etc.). The company needs to be nominated by a current member and thereafter endorsed by a board member. Max. 8 members + partner/companion: the representative members can be changed yearly, Additional advantages for a company membership: 1 company presentation (max. 15mins) in one of the AAAA meetings on a first come, first serve basis, and thereafter due to continuous membership once a year a 15 minute company presentation/promotion (in mutual agreement with the board members) and one free advertisement of the company in the AAAA newsletter per year.

- EUR 1000 initial fee
- EUR 500 yearly fee



# MEMBERSHIPS

## **4. Honorary Membership**

Any individual person over the age of 16 years and nominated by the board due to his/her special dedication in the association, special contributions for Austria / Asia / Africa, or social and political position are allowed to become an honorary member. For the nomination process to be approved, there needs to be a majority vote of the board achieved. The honorary membership is a lifetime status, free of charge, and can only be revoked due to serious defiance of the AAAA charter.

# AAA ART AND ECONOMIC FORUM

A unique forum taking place on a yearly rotational basis in Austria, Asia, and Africa. The first anticipated forum will take place in the fall of 2021 in Austria. As the title already suggests, a vital business exchange with interesting presentations of business leaders showcasing opportunities in Central Europe, as much as hubs of great interest in Asia and Africa is taking place in a unique artistic environment. Three pre-selected artists chosen from a competition in the three-name-sake areas of the association will present their unique creations to vie for the ultimate prize awarded during the gala event highlight of the forum.

## MEMBERS' MEETINGS

**The members' meetings will take place periodically in Austria in summer and Christmas period, and in South Africa, Kenya, and China on a regular basis.**

The evenings of the members' meetings are planned as a culinary and informative highlight in the agenda of each member. These events usually take place in unique and historical locations.

Another constant programme will be interesting lectures on topics related to Asia and/or Austria by a member or a guest speaker e.g. country ambassador, business leader or artist. New members will also be introduced and inducted to AAAA.

Additional meetings in the future will take place in Asia and Africa.

In all these events, we promote the deepening of contacts between the individual members through joint events, talks and meetings. Through interesting lectures from the fields of economics, finance and politics, the members are informed about the economic potential of Austria and Asia and cooperation is supported and promoted. The culinary highlight would be a well-chosen menu e.g. from an Austrian Michelin Star chef who is in Asia at this time or an Asian chef from a renowned local restaurant.

As part of the meetings, the AAAA members visit selected projects and institutions under the AAAA Charity Program, to get to know them personally and also to hand over the donations personally and on site.

## CHARITY PROJECTS

**An important goal of the AAAA is the support of disadvantaged children in Asia and Africa through the charity program.**

At the annual meeting in Asia / Africa, members have the opportunity to visit and get to know the selected projects and institutions. In 2015, members visited Wat Sra Kaew orphanage in Angthong, Thailand for the first time. There, a lunch including dessert was sponsored for 2,200 children and distributed with the active assistance of the present members. In total, the AAAA was able to hand over a donation of € 2,500 to the orphanage.

In 2016 the AAAA donated over € 3,000 to the Sprouts Foundation, which develops and supervises educational programs for disadvantaged children in Hong Kong.

In 2020, the charity actions are split into 2 projects in Nepal. One project is a school library for a vocational training school, with USD 5,000 to equip it with books and computers. Another project is to convert the school into a safer place, which AAAA will donate USD 14,000 in total over a 3-year project in support of Right4Children.

In order to offer children a better future and new perspectives, the AAAA will continue to support various projects with donations in the Asian and African regions over the next few years.
